SECTION 4. FIRST AID MEASURES

If poisoning occurs, immediately contact a doctor or Poisons Information Centre (telephone 13 11 26), and follow the advice given. Show this Material Safety Data Sheet to the doctor.

Skin contact

Wash off thoroughly with plenty of soap and water, if available with polyethyleneglycol 400, subsequently rinse with water.

Eye contact

Rinse immediately with plenty of water, also under the eyelids, for at least 15 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Get medical attention if irritation develops and persists.

Ingestion

Call a physician or poison control center immediately. Rinse mouth. Induce vomiting only, if: 1. patient is fully conscious, 2. medical aid is not readily available, 3. a significant amount (more than a mouthful) has been ingested and 4. time since ingestion is less than 1 hour. (Vomit should not get into the respiratory tract).

Notes to physician

Treatment

Treat symptomatically. Monitor: Respiratory and cardiac functions. In case of ingestion gastric lavage should be considered in cases of significant ingestions only within the first 2 hours. However, the application of activated charcoal and sodium sulphate is always advisable. There is no specific antidote.

SECTION 5. FIRE FIGHTING MEASURES

Suitable extinguishing media

Use water spray, alcohol-resistant foam, dry chemical or carbon dioxide.

High volume water jet.

Precautions for fire-fighting

Wear self-contained breathing apparatus and protective suit. Contain the spread of the fire-fighting media. Do not allow run-off from fire fighting to enter drains or water courses. Remove product from areas of fire, or otherwise cool containers with water in order to avoid pressure being built up due to heat.

SECTION 6. ACCIDENTAL RELEASE MEASURES

Personal precautions

SECTION 13. DISPOSAL CONSIDERATIONS

350 g pack

Dispose of empty container by wrapping in paper, placing in plastic bag and putting in the garbage. DO NOT burn empty containers or product.

Metal drums and plastic containers > 350 g

Triple or preferably pressure rinse containers before disposal. Add rinsings to spray tank. Do not dispose of undiluted chemicals on site. If recycling, replace cap and return clean containers to recycler or designated collection point. If not recycling, break, crush or puncture and bury empty containers in a local authority landfill. If no landfill is available, bury the containers below 500 mm in a disposal pit specifically marked and set up for this purpose clear of waterways, desirable vegetation and tree roots. Empty containers and product should not be burnt.
